

VISTRA FREIGHT ROUTING INSTRUCTIONS

- **ALL shipping documents, as well as packaging and packing lists, MUST contain Vistra's PO#.**
- **Account numbers and Instructions vary by ship-to-location and by shipment type.**
- **COD (cash on delivery) shipments may be rejected.**
- **All material shall be properly palletized and secured to allow safe unloading with material handling equipment.**
- **Failure to follow the instructions below may result in a short pay or payment refusal situation as Vistra reserves the right to deny the payment of any freight-related charges on non-compliant shipments.**

1. BEAVER VALLEY, DAVIS-BESSE, or PERRY NUCLEAR POWER PLANTS

- Schedule all freight (both parcel and non-parcel / domestic or international) thru online routing guide at <https://vistrafreight.com>
- If shipment cannot be scheduled electronically through the online routing guide, or if shipment requires special handling, contact Ardmore Power Logistics (800-349-7619)
- Bill THIRD PARTY to Ardmore Power Logistics
- Oversized loads to be delivered on flatbed; box trucks with oversized loads will not be accepted
- Prior notification required if more than 4,000 lbs TOTAL per material/pallet; if oversized items must be off loaded from the side of a flatbed; if an overhead crane is required; or if an entire truck load of material
- For directions to warehouses, call 888-823-7447
- No shipments will be accepted outside the following warehouse receiving hours or on U.S. major holidays

2. ALL OTHER LOCATIONS

Parcel – Use FedEx **account #2024-4213-5** (ground or air); phone 800-463-3339

- Include PO # in Ref Field 1 of the Billing Details section
- Mark shipping documents as **Bill Recipient**
- Use FedEx for parcel shipments only; do not use FedEx LTL Freight.
- Small Package not to exceed 70 lbs weight and 24"x24"x24" dimensions
- Express Air Shipments not to exceed 150 lbs. and 119" Length or 165" combined Length and Width
- Parcel not to be used for materials valued \$10,000+

- Include Vistra PO# on all shipping and billing documents
- Bill COLLECT to Vistra, c/o Broussard Logistics, PO Box 130506, Dallas, TX 75313
- Do not use LTL for urgent/time-sensitive deliveries
- LTL not to be used for materials valued \$25,000+
- LTL to Texas ship-to-locations (all other locations contact Broussard Logistics)
