**ALL shipping documents MUST contain Luminant's P.O.#.**

**Fed Ex Parcel: Use FedEx Account# 1216-6795-9 (ground or air) – phone 800-463-3339**

- Small Package not to exceed 70 lbs weight and 24"x24"x24" dimensions
- Express Air Shipments not to exceed 150 lbs. and 119" Length or 165" combined Length and Width
- Use for Parcel shipments only. Do not use FedEx LTL Freight
- Include PO# and mark shipping documents as **Bill Recipient**
